The Fatality Review Committee attempts to identify all domestic violence related fatalities in the state of Colorado. The information is collected from newspaper articles, as well as press releases from law enforcement.

2005 Domestic Violence Related Fatalities

Total of 36 incidents resulting in 50 Fatalities

- 27 Murders of Intimate Partners
(24 Females killed, 3 males killed)
- 2 male children killed by their father
- 6 collateral fatalities
(1 brother in law, 3 friends of the victim, 1 old partner, 1 divorce attorney of victim)
- 13 Male perpetrator suicides
- 2 Male perpetrators killed by another (victim, friend of victim)

In those 50 fatalities, a firearm was used in 78% (n=39) of the cases
